Route #1 service begins at 7:05 am every weekday during the legislative session with service every 1/2 hour. This is a fixed route service. Drivers will not deviate from their assigned schedule or make un-scheduled stops along their assigned route. The last passenger pickup will occur at the Capitol Building, at 6:50 pm. The last van departing from the Capitol Building will deliver passengers to the NMDOT General Office, Montoya Building and Alta Vista Street, but will not pick up passengers at those stops.

Stop Locations:

- NMDOT General Office, 1120 Cerrillos Road (front of building by the flag pole)
- Montoya Building, South Capitol Complex (at the flag pole facing the rail tracks)
- Alta Vista Street, (south side of the street, between Pen Road and St. Francis Drive)
- State Capitol, (in the small parking lot adjacent to the east entrance)

Route #2 service begins at 7:00 am every weekday during the legislative session with service every 45 minutes. This is a fixed route service. Drivers will not deviate from their assigned schedule or make un-scheduled stops along their assigned route. *The van serving this route will make a 30 minute detour for re-fueling and driver change between 12:45 and 1:15 p.m. The last passenger pickup will occur at the Capitol Building, at 7:00 pm. The last van departing from the Capitol Building will deliver passengers to the Toney Anaya Building, ARK/Pollon and San Mateo Plaza, but will not pick up passengers at those stops.

Stop Locations

- Toney Anaya Building, 2550 Cerrillos Road (vans stop at the front of building facing Cerrillos Road)
- ARK / Pollon, 2009 Pollon Plaza (vans stop between the two buildings on the east side of Pacheco Street just south of St. Michael's Drive)
- San Mateo Plaza, 604 West San Mateo Road (vans stop at the buildings main entrance on the west side of the building)
- State Capitol (in the small parking lot adjacent to the east entrance).

Route #3 service begins at 7:00 a.m. every weekday during the legislative session. This is a fixed route service. Drivers will not deviate from their assigned schedule or make un-scheduled stops along their assigned route. *The van serving this route will make a 30 minute detour for re-fueling and driver change between 12:30 and 1:00 p.m. The last passenger pickup will occur at the Capitol Building, at 6:30 pm. The last van departing from the Capitol Building will deliver passengers to the De Vargas Mall and United Methodist Church, but will not pick up passengers at those stops.

Stop Locations

- St John's United Methodist Church, on Old Pecos Trail and East Barcelona Road. (Parking and bus boarding will be behind the Church adjacent to Barcelona Road.)
- State Capitol. (The vans stop in the small parking lot adjacent to the east entrance.)
- De Vargas Mall. (Parking and boarding will be at the west end of the mall by Office Depot.)
